DISTRICT HIGHLIGHTS

* Students in Debra Hessner's Second-Grade Class at the Eisenhower Elementary School participated in Greg Tang's March Mathness Contest from March 18 through March 28, 2014. The students played a game called Kakooma, which is a timed addition game. They competed as a class to earn top scores. Students worked both in school on the Chromebooks and at home on the website. There were over 900 schools participating nationwide. At the close of the contest, Ms. Hessner was informed that her class finished in First Place with a top score of 60 in the K-2 bracket nationwide. According to the website, their prize is a \$100 Pizza Hut gift card and a signed book from Greg Tang. Congratulations to Ms. Hessner and her class for a job well done!

* The Art Department at the Sayreville War Memorial High School is proud to announce that three of our students have advanced in the 2014 Congressional Art Competition to the national level. These students competed at the state level and have been chosen as three of the top eighteen pieces from the State of New Jersey. The students' art will now

travel to the nation's Capital. They will be competing against the nation's finest artists in the next level of the competition. Congratulations to Ilona Scarbonne, Selena Siri and Alicja Wisniowska!

* Michelle Leonard, a fifth-grade language arts teacher at the Samsel Upper Elementary School, organized Operation Smile for the Camera during the week of March 17. Students paid to have their picture taken in a photo booth with their friends, using costumes, hats and other props. More than \$1,000 was raised to benefit Operation Smile, a nonprofit organization that provides free reconstructive surgery to children who are underprivileged and born with cleft palates and other facial deformities. The amount is enough to provide four surgeries to children in need. On one of the days, Steven Kelly, a survivor of 14 surgeries for a double cleft palate and cleft lip, came in to share his story with the students during the lunch periods. This idea stemmed from the book "Wonder" by R.J. Palacio, which Mrs. Leonard read with her students. The main character, August, was born with a genetic disorder that resulted in severe facial deformities and a cleft palate. The book centers on the themes of anti-bullying and kindness. Thank you, Mrs. Leonard, for your efforts!

* The Sayreville War Memorial High School Boys' Track 4x100 meter relay team made history the weekend of April 26th as they became the first Sayreville team ever to advance to the finals of the Penn Relays – the most prestigious track meet in the US. On Friday, the boys broke the school record, running a time of 42.42 on their way to a 3rd Place finish in the finals. In the event, 248 teams from around the world competed, making their bronze medal performance even more impressive. Congratulations to Myles Hartsfield, Shaun Abubakar, Linwood Crump and Colin Winslow on their historic performance last weekend!

* The Sayreville War Memorial High School recognized May 1st, which is National College Decision Day, as the deadline to accept admission at a four-year school. Many of our seniors have made their final selection. The school will recognize this milestone by having a "Support your School" day. NOW, THEREFORE BE IT RESOLVED, that the Sayreville Board of Education hereby establishes the school district travel maximum for the 2014-2015 school year at the sum of \$17,000 and be it further resolved that the School Business Administrator shall track and record these costs to insure that the maximum is not exceeded. Current 2013-2014 school-year expenditures are \$6,713.40 and budget is \$17,000.
