BUILDINGS AND GROUNDS

1. The Board of Education approved use of one classroom space per school at Sayreville War Memorial High School, Sayreville Middle School and Eisenhower Elementary School on July 1, 2, 3, 2014, 8:00 AM – 4:00 PM each day for filming of LEGAL ONE/FEA/NJPSA professional administrative training video.
