1. The Board of Education is requested to approve a donation of a flat screen Dell monitor and a set of computer speakers for Truman School, 2A1 classroom.

2. The Board of Education is requested to approve the following resolution:

WHEREAS, the Sayreville Board of Education (“Board”) and the taxpayers of the Sayreville Public School District will benefit from a contract for either 1) the full funding for, or 2) construction and installation of, a new stadium scoreboard; and

WHEREAS, the Board intends to solicit quotations and potentially award a concession contract to a vendor who fully funds or constructs and installs a new stadium scoreboard in return for the right to advertise its business or organization thereon for a period not to exceed five (5) years; and

WHEREAS, the Board has considered and balanced the benefits of receiving a scoreboard or the funding thereof in exchange for advertising against the absence of any reasonable potential for risks involved in awarding a contract for such services; and

WHEREAS, the Board estimates that the cost of either option will be below the current bid threshold; and

WHEREAS, the award of the stadium scoreboard concession shall be based upon the most advantageous proposal, price and other factors considered pursuant to N.J.S.A. 18A:18A-36(a) and N.J.A.C. 5:34-9.4(g); and

WHEREAS, the Board estimates that it will incur no costs as a result of the stadium scoreboard concession; and

WHEREAS, the solicitation shall require that any advertisement be in accordance with Board policy and be compatible with the Board’s educational goals and objectives; and

NOW, THEREFORE, BE IT RESOLVED that the Board authorizes the procurement of a new stadium scoreboard as a concession pursuant to N.J.S.A. 18A:18A-1, et seq., N.J.A.C. 5:34-9.4; and

BE IT FURTHER RESOLVED that the Business Administrator/Board Secretary is hereby authorized to solicit and receive informal quotations from prospective vendors and to award a contract for such services to the vendor that offers the most advantageous proposal, price and other factors considered.

The Board of Education is requested to approve the following resolution:

WHEREAS, P.L. 2011, c. 202 authorizes changing the date for the election of school board members from the third Tuesday in April to the first Tuesday after the first Monday in November (the General Election); and

WHEREAS, such action requires the adoption of a resolution by the board of education or the municipality constituting the school district; and

WHEREAS, P.L. 2011, c. 202 requires that the change to a November election remain in effect for four years; and

WHEREAS, P.L. 2011, c. 202 eliminates the annual vote referendum on the proposed general fund tax levy (i.e., the base budget which is at or below the statutory tax levy cap) in school districts where board of education members are elected at the General Election; and

WHEREAS, P.L. 2011, c. 202 requires that an additional general fund tax levy proposal (i.e., for an expenditure in excess of the tax levy cap) be presented to voters as a separate question at the General Election.

NOW, THEREFORE, BE IT RESOLVED, that, pursuant to P.L. 2011, c. 202:

1. The Sayreville Board of Education changes the annual election date for school board members from the third Tuesday in April to the November General Election, beginning in 2013; and

2. The annual organization meeting of the Sayreville Board of Education will take place in the first week of January following the November General Election and t
3. Members of the Sayreville Board of Education whose terms would have expired by May 2013 will continue to serve in office until the January 2014 organization meeting; and
4. Copies of this resolution shall be transmitted to the Middlesex County Clerk; the Middlesex County Board of Elections; the Sayreville municipal clerk; the Department of State, Division of Elections; the Executive County Superintendent for Middlesex County; the Department of Community Affairs, Division of Local Government Services; the New Jersey School Boards Association and the New Jersey State League of Municipalities.
